Eligibility: The competition is open to all artists over the age of 18, in the following media:

Painting/Drawing 3D Art Photography

Specifications: All works must have been completed in the last three years and not previously submitted to the Columbus Arts Council. No NFS (not for sale) in show. Maximum dimensions are 48 inches in any direction, including frames and cannot be heavier than 100 pounds. Works must arrive in frames (paintings/photographs) and ready to hang or install. Must have ID in lower left corner on back of art – include artist's name, price, title and type of medium – pottery/statues should have ID on bottom.

JPEG Submissions: For submissions please send CD with jpeg images 600 pixels in height or 600 pixels in width. All submissions must be on one CD and a printout with the image and the title, size, medium and completion date must accompany the application form and fee via mail. Images of 3D Art can be shown in more than one view. **Do not email images.**

Entry & Handling Fee: Artists may enter up to (3) three works per medium for a **\$30.00 fee**, additional mediums can be submitted. **Fees are non-refundable.** Make Juried Art checks separate from vendor checks and payable to Columbus Arts Council. Three-dimensional work may be represented by two images (different views); these two will be counted as a single work. **Completed entry form with appropriate fee and CD must be postmarked on or before March 25, 2010.** No late entries will be accepted. No refunds.

Accepted Works: Pieces chosen from submitted slides or jpegs must be hand-delivered to the Rosenzweig Arts Center arriving *no later than Friday, May 7th at noon.* Each work should be labeled exactly as it was listed on the entry card. Prices or other details may not be changed. No substitutions for accepted works or changes to the submitted entry card will be permitted. Work may not be withdrawn before the close of the exhibition. Decisions are final. **All work must be picked up between 4 pm and 5 pm on the day of the festival or they will become property of the Arts Council.**

Sales and Commissions: The CAC encourages sales to the public and will charge a 20% commission on all work sold during the exhibition. MS sales tax plus commission must be paid to CAC by 5 p.m. on the day of Festival.
